- knowledge on and observance of the access rules in restricted access areas (ISPS Code);
- inspection on the accurate and proper keeping of Oil Record Book and Garbage Book:
- placement of schedules, signs and symbols at designated areas;
- proper keeping of the record for work and rest hours of the crew.

The results of the above inspections shall be reported in Form F705-10.2010 (available in the server) upon each inspection of the ships sailing under Bulgarian flag.
